Reason:	Appeared to be excellent examples of two 1923 hotels in San Pedro. The eastern building, at 251-259 W 7th Street, was built in 1923 by Gustave Litschke as the Mission Hotel. The western building, at 261-263 W 7th Street, also 1923, was built by Nick Papadakis as Hotel La Salle. In the 1940s, Papadakis purchased the Mission Hotel and combined the two buildings into a single hotel. In 2008, the two buildings were redeveloped; the facades were retained and renovated, with new construction at the rear. The hotel facades appear to have been substantially modified during the redevelopment project. Due to alterations to the facades and new construction behind, the property does not retain sufficient integrity to be eligible for listing.

	<p>Marabella Vineyard Co. was originally established during Prohibition as a grape juice manufacturer for home winemakers, when it was legal to buy juice but not wine. Today, this family business is run by the fourth generation using the original equipment. The business has occupied the current building since 1957. The property appears to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.</p>

Reason:	Rare example of early-20th century industrial development in San Pedro; few examples remain from this period. Also a rare remaining example of an industrial building associated with the shipping industry in San Pedro. This building was originally constructed in 1910 as a laundry plant that washed clothes and linens for cargo ships calling at the Port of Los Angeles. In 1953, the use changed from a laundry plant to a warehouse for Harbor Ship Supply, a ship chandler. In 1995, it was converted into artist lofts.
