These streetlights/trolley poles were installed in the 1920s and 1930s to support the 600-volt DC wires which supplied power to the West 2nd Street Cable Railway line. These streetlights appear to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.

In the mid-1920s, hundreds of these streetlights were installed in downtown Los Angeles and extended outward along several major streets. Note that the full extent stretches west of Union (into the Westlake CRA area). These streetlights appear to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.

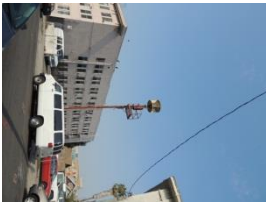

Reason:	Excellent example of a residential tract feature in Westlake. This landscaped median and street trees were installed as part of the original Occidental Park tract in 1905. The median was originally requested by developers of the Occidental Park tract to protect the thoroughfare from encroachment by telephone poles. The request for the median was embraced by the city park department, as it was hoped it would become part of a continuous system of "parkways" linking Griffith Park, Agricultural Park (now Exposition Park), Sunset Park (now LaFayette Park) and Westlake Park (now MacArthur Park). Set in the center of the 120-foot wide roadway the median is 20 feet in width and a half-mile in length. The improvements were installed and maintained by the park department. When completed, this stretch of Occidental Boulevard was praised as one of the handsomest boulevards in Los Angeles. While a system of interconnected parkways was never realized, this median does link to LaFayette Park at its southern terminus. The landscaped median and street trees appear to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.

Streetlights with "dragon arm" support and "stemware platter of fruit" finial, "Olympic Special" style, located along both sides of Olympic Boulevard between Hoover Street on the west and the 110 Freeway on the east. In the 1920s and 1930s, Olympic Boulevard was decorated with this style of streetlight from downtown Los Angeles to West L.A. Today, some examples display the original "tear drop" pendant luminaire, while others have been retrofitted with modern cut-off luminaires. Note that the full extent stretches west of Hoover (into the Wilshire CPA) and east of the 110 Freeway (into the Central City CPA). These streetlights appear to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.

Shatto only occupied the residence for a short time, as he was killed in a railroad accident in 1893. Eventually, Good Samaritan Hospital would replace all of the residences along this stretch of Orange Street (later Wilshire Boulevard). Today, two remnants of the original rusticated stone wall are all that remain of this elaborate residence; the other remnant is situated on Lucas Avenue at Wilshire. The wall appears to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.

	<p>rectangular lanterns, "Wilshire Special" style, located along both sides of Wilshire Boulevard, between Union Avenue on the west and the 110 Freeway on the east. In the 1920s and 1930s, Wilshire Boulevard was decorated with this style of streetlight for nearly six miles of its length. Approximately 100 streetlights still remain over a distance of one-and-a-half miles. The original lanterns are solid bronze and measure seven-and-a-half feet tall from the base to the top of the finial. Note that the full extent stretches west of Union (into the Westlake CRA area), and east of the 110 Freeway (into the Central City CPA). These streetlights appear to meet local criteria only and may not meet significance thresholds for National Register or California Register eligibility.</p>
